AN ACT TO AMEND THE CONSTITUTION.

[27th June, 2012]

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 29 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of
Article 29 of the
Constitution.

1.—Article 29 of the Constitution is hereby amended as follows:

- (a) the subsection, the text of which is set out in *Part 1* of the *Schedule*, shall be inserted after subsection 9^o of section 4 of the Irish text,
- (b) the subsection, the text of which is set out in *Part 2* of the *Schedule*, shall be inserted after subsection 9^o of section 4 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Thirtieth Amendment of the Constitution.

(2) This Act may be cited as the Thirtieth Amendment of the Constitution (Treaty on Stability, Coordination and Governance in the Economic and Monetary Union) Act 2012.
